Please include the relevant budget band and position credit as Intimacy Coordinator or Lead Intimacy Coordinator on the project, and return to me via the preferred digital signing platform.

For clarity, the budget bands which appear on the Bectu Intimacy Coordinators Ratecard are:

Scripted TV:

- BAND 1: under £1.25 Million per broadcast hour
- BAND 2: £1.25-£3 Million per broadcast hour
- BAND 3: £3-8 Million per broadcast hour
- BAND 4: £8 Million+ per broadcast hour

Film:

- Student/Short Films – Under £150K
- Micro-budget feature films – Under £1 Million
- Low budget feature films - £1-£5 Million
- Medium budget feature films - £5-£15 Million
- High budget feature films - £15-£30 Million
- Premium budget feature films (Major Motion Pictures) - £30 Million +
